#### Rescue Package for Montana's At-Risk Youth - Education for Life

Amount: \$534,500

Jobs for Montana's Graduates Foundation (Helena, MT)

This project will expand Jobs for Montana's Graduates' successful dropout prevention program to disadvantaged youth while incorporating high-wage, high-demand career exploration activities for at-risk students in areas such as energy and green

technology.

## Rocky Boy Health Board Equipment Upgrades

Request Subcommittee Committee Senate Floor Conference Law

Amount: \$800,000

Rocky Boy Health Board (Box Elder, MT)

Funds will be used to purchase telecommunications equipment, x-ray equipment, optometry equipment, dental equipment, and boiler updates. The new equipment will allow the tribal health board to provide essential medical care to reservation residents such as telemedicine opportunities for reservation patients that are currently transported to off-reservation hospitals. The Health Care Facility serves the Tribe with a total of about 5500 members with more than half residing on the reservation.

# Rural Health in America: Pharmacist Patient Care and Drug Therapy

Amount: \$360,000

University of Montana (Missoula, MT)

This program will construct programs for Medication Therapy Management and the "Medical Home" using collegial and collaborative drug therapy management methods to work in concert with and under the auspices of physicians to improve drug therapy in the difficult-to-access populations.

#### Rural Kids Telemental Healthcare Initiative

Youth Dynamics, Inc. (Billings, MT)

This project incorporates a creative approach to provide access to quality behavioral treatment by using state-of-the-art telemental health care technology in each of its locations to deliver therapeutic services targeted to children and youth living in Montana rural and remote areas.

#### Saint John's Lutheran Hospital Facilities and Equipment

Request Subcommittee Committee Senate Floor Conference Law

Amount: \$1,500,000

Saint John's Lutheran Hospital (Libby, MT)

This project will help with hospital expansion, as months of professional planning and research found that about 77,000 additional square feet is needed to meet demands including a 29 percent increase in surgical cases and a 71 percent increase in emergency room visits.

#### Saint Patrick Hospital and Health Sciences Center

Request Subcommittee Committee Senate Floor Conference Law

Amount: \$1,800,000

Western Montana Telemedicine Network (Missoula, MT)

This project will create a permanent, shareable, web-based, secure, HIPAA-compliant Electronic Health Record system to connect all hospital information systems, clinics, and physicians in the region. It will enable all Western Montana health care providers (12 hospitals, 600 providers, 300,000 patients) to communicate in real-time to compare the effectiveness of different medical treatments.

#### Southcentral Montana Workforce Incubation and Retention Center

Request Subcommittee Committee Senate Floor Conference Law

Amount: \$100,000

Montana State University, Billings (Billings, MT)

This project will maintain state of the art services and facilities, such as computer labs and distance learning centers, and provide access to expert trainers and best training practices benefiting the employer, employee, and the regional economy.

#### Tobacco Valley Community Center

Request Subcommittee Committee Senate Floor Conference Law

Amount: \$300,000

Tobacco Valley Senior Citizens Association (Eureka, MT)

The Tobacco Valley Senior Citizens Center is currently housed in a converted church dating back to 1906. Realizing the limitations of the current Center, this project will help seniors further develop the senior and community center.
